Sub: **Representations of students regarding amendments in the relevant clauses of the examinations ordinances no. 10, 11, 21, 25, 27 & 29.**

Dear Madam / Sir,

The University discussed the issues in the light of the University Office Order No.F.2(29)/Ord/IPU/ADRP/2009/11446 dated 24/08/2009 which was distributed to all Deans, University Schools of Studies and Principal / Director of all Affiliated Institutions. The amendments in the relevant clauses of University Examination Ordinances no. 10, 11, 21, 25, 27 & 29 were conveyed to all Head of the Institutions on August 25, 2009 which was the time when the academic session had just begun. These ordinances were amended in the meeting of the Board of Management held on June 29th, 2009 and came into force w.e.f. the date of approval i.e. 29/06/2009.

Keeping in view the approval of the Board of Management as on June 29th, 2009 and Office Order No. No.F.2(29)/Ord/IPU/ADRP/2009/11446, dated 24/08/2009, university is of the view that there is no merit in the representations of students. In the prospectus of academic session 2009-10, it was also mentioned on page 71 that :

"It may be noted that students taking admission in any of the programmes/Institutes will also be bound to abide by the provisions of Guru Gobind Singh Indraprastha University Act, 1998 as well as Statues, Ordinances and Regulations framed there under."

Hence, the representations of the students have no merit and may not be considered.
